**Important Instructions for the candidates:**

- ❖ Candidates are permitted to carry only the following items into the examination hall (**BALL Point PEN Blue only**), **admit card, personal hand sanitizer, face mask, and valid ID proof**. The Candidates who doesn't possess valid ID proof shall be debarred from writing exam.
- ❖ Candidates shall be allowed to leave the examination hall only after 1 hour of examination.
- ❖ No candidates shall be allowed or entertained once the examination starts.
- ❖ The admit card is not transferable to any other person. Impersonation if found, the candidature shall be cancelled from writing exam.
- ❖ Candidates must reach the examination centre 1 hour prior to the examination time for thermal Scanning and if any candidates found their body temperature more than normal he/she shall be arranged to sit in the isolation/separate room.
- ❖ Candidates must maintain strict Standard Operating Procedures (SOPs) physical distancing, wearing face mask and carrying pocket sanitizer.
- ❖ Prohibited items such as books, paper chits, electric gadgets such as (Mobile phone, Head Phones, Pen Cameras/Buttonhole Cameras, calculator etc) are **STRICTLY NOT ALLOWED** in the examination Hall. In case they bring any such item, they will have to make their own arrangements for safe custody and If any such item is found in the possession of a candidate in the examination hall, his/her candidature is liable to be cancelled and legal proceedings may be initiated against him/her. He/she will also liable to be debarred from appearing in future examination of the Council for a period of 5 years.
- ❖ On Completion of examination candidates must handover the answer sheet to the invigilator. Failure to do so will treated as adoption of unfair means and will be dealt accordingly.
- ❖ No candidates should adopt any unfair means or indulge in any unfair examination practices.
