## //CIRCULAR//

This is in compliance to the 16<sup>th</sup> Council meeting dated 8<sup>th</sup> August '2020 and in pursuant to the directives of INC guidelines of even no. dated 14<sup>th</sup> May 2020 and 11<sup>th</sup> July 2020 on academic and examinations during COVID – 19 pandemic.

## **Guidelines for Examination:-**

- (a) The examination of final year students will be commenced from 7<sup>th</sup> October '2020. They shall be appearing both Theory and Practical examination. Hence students have to report to school before 20<sup>th</sup> September '2020. Student failed in subjects will have to appear in the supplementary exams.
- (b) Keeping in view of persistent COVID-19 pandemic, examinations for 1st year ANMs students and 1st and 2nd year GNMs students shall not be conducted. They shall be promoted to next higher classes or the next academic year on the basis of internal evaluation and performance in school exams in theory and practical examination as per the following grading:-
  - (i) 50% marks on the basis of the pattern of internal assessment of student
  - (ii) And the remaining 50% marks on the basis of average of performance in school examinations during the entire year (theory and practicals)
  - (iii) If average of performance in school examinations during the entire year is not available then 100% evaluation may be done on the basis of internal assessment.
- (c) No institution shall submit average internal marks of the test students more than 75% as specified in curriculum note of INC syllabus.
- (d) Students having back log subjects of 1st year ANM students and 1st and 2nd year GNM students prior to the COVID-19 pandemic have to be appeared in the supplementary exams as usual as per APNC exam guidelines.

N.B: National directives of 'SOP' for COVID - 19 pandemic must be maintained during examination.
